



#### 1. Access to the Service:




# 2. Service Steps:


- 1.Enter main application data, which varies according to the purpose of using the certificate:
- 1.1. If you select **use inside the country**, you should enter the Issuance Emirate, reason, language of the certificate and others, then click on **next** button.




1.2. If you select **use outside the country**, enter the issuance Emirate, requesting country and delivery method, then click on **next** button.




2. Check fees details, accept the terms and conditions then click on **next** button to proceed.




3. Click **YES** to be redirected to the payment gateway




4. You will be redirected to the payment gateway to complete payment process








# • Certificate Attestation Steps:


 Navigate to your Police Clearance Certificate application then click on Certificate Attestation button. Please note that the Certificate Attestation option is displayed for completed applications only.
